## PRIVACY POLICY

Brynsløkken AS is committed to protecting your privacy. This Privacy Policy explains how your personal information is collected, used, stored, and disclosed by Brynsløkken AS in accordance with the **General Data Protection Regulation (EU) 2016/679 (GDPR)** and applicable Norwegian law.

## What Information Do We Collect?

We collect information from you when you visit our website, order a MSDS, respond to a survey or fill out a form.

The following information is collected:

- IP-address
- Name
- Phone Numbers
- Email Addresses
- Company name

We only collect personal data that is necessary for the purposes described in this Privacy Policy and in accordance with applicable data protection laws.

## How Do We Use The Information We Collect?

Your personal data can be used for the following purposes:

- To respond to inquiries and provide customer support
- To process MSDS requests and other transactions
- To improve our website and services
- To comply with legal and regulatory obligations



## How Long Do We Keep Your Information?

We keep your information only so long as we need it to provide Brynsløkken AS to you and fulfill the purposes described in this policy. When we no longer need to use your information and there is no need for us to keep it to comply with our legal or regulatory obligations, we'll remove it from our systems. Retention periods vary depending on the type of personal data and the purpose of processing.

## How Do We Protect Your Information?

We implement security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information.

These measures include:

- Access control for all employees
- Secure storage of information
- Use of trusted IT-services

We cannot, however, ensure or warrant the absolute security of any information you transmit to Brynsløkken AS or guarantee that your information on the Service may not be accessed, disclosed, altered, or destroyed by a breach of any of our physical, technical, or managerial safeguards.

## Your rights

You have the right to access, correct, or delete your personal data, to request restriction or object to processing, to data portability, and to withdraw consent at any time. You also have the right to lodge a complaint with the Norwegian Data Protection Authority (Datatilsynet).

## Your Consent

We've updated our Privacy Policy to provide you with complete transparency into what is being set when you visit our site and how it's being used. Where processing of personal data is based on consent, such consent is obtained explicitly and may be withdrawn at any time without affecting the lawfulness of processing carried out before withdrawal.

## Cookies

We use cookies and similar technologies in accordance with applicable cookie and ePrivacy rules. Non-essential cookies, including analytics and marketing cookies, are only used with your explicit consent, which can be managed through our cookie banner. We use Cookies to enhance the performance and functionality of our website but are non-essential to their use. However, without these cookies, certain functionality like videos may become unavailable or you would be required to enter your login details every time you visit the website as we would not be able to remember that you had logged in



previously. Most web browsers can be set to disable the use of Cookies. However, if you disable Cookies, you may not be able to access functionality on our website correctly or at all. We never place Personally Identifiable Information in Cookies.

### **Kids' Privacy**

In accordance with Norwegian law, the age of digital consent is 13 years. We do not address anyone under the age of 13. We do not knowingly collect personally identifiable information from anyone under the age of 13.

### **Changes To Our Privacy Policy**

We may change our Service and policies, and we may need to make changes to this Privacy Policy so that they accurately reflect our Service and policies. Unless otherwise required by law, we will notify you (for example, through our Service) before we make changes to this Privacy Policy and give you an opportunity to review them before they go into effect. Then, if you continue to use the Service, you will be bound by the updated Privacy Policy. If you do not want to agree to this or any updated Privacy Policy, you can delete your account.

### **Third-Party Services**

The information you share with us can be shared with service providers (web suppliers, designers and IT-support) and if required by law, public authorities.

Such service providers process personal data only on our instructions and in accordance with data processing agreements.

### **International data transfers**

If we transfer personal data outside the EU/EEA, we ensure that appropriate safeguards are in place in accordance with the GDPR.

These may include:

- Standard Contractual Clauses approved by the European Commission
- Transfers to countries subject to an adequacy decision
- Where necessary, supplementary measures and risk assessments
